RJEŠENJE

1. U Registru udruženja Ministarstva pravde Bosne i Hercegovine, kod Udruženja Centar za energiju, okolinu i resurse, sa sjedištem u Sarajevu, ulica Podgaj broj 8, upisanog pod registarskim brojem: 385, Knjiga I Registra, dana 12.1.2006.godine, upisuju se promjene, kako slijedi:

- Izmjena i dopuna Statuta Udruženja broj: 03/13 od 15.7.2013. godine;

Mijenja se znak Udruženja tako da isti glasi:

Znak Udruženja sastoji se od simbola i tekstualnog dijela. Simbol se sastoji iz tri elementa uključujući tri krivulje od kojih se jedna krivulja završava sa kapljicom, druga sa listom dok treća najveća spaja navedene elemente u jednu cjelinu. Tekstualni dio se sastoji od skraćenog naziva i punog naziva Udruženja na engleskom jeziku. Skraćeni naziv Udruženja napisan je velikim slovima, font Merge Light tirkiznom bojom, a puni naziv Udruženja na engleskom jeziku ispisan je fontom Verdana tamnije tirkizne boje.

- Razrješava se Nadira Berbić potpredsjednica Udruženja, za zastupanje Udruženja u pravnom prometu.
- Za zastupanje Udruženja u pravnom prometu, upisuje se:
 - Sadžida Hafizović, potpredsjednica Udruženja pored
 - Šejle Mahmutović, predsjednice Udruženja, koja zastupa Udruženje prema Rješenju broj UP09-07-1-1867/21 od 19.10.2021. godine.

Udruženje Centar za energiju, okolinu i resurse, sa sjedištem u Sarajevu, ulica Podgaj broj 8, upisano je u Registar udruženja pod registarskim brojem: 385, Knjiga I Registra, dana 12.1.2006.godine.

Podnositelj Zahtjeva je 16.6.2023. godine podnio Zahtjev za upis promjena u Registru udruženja ovog Ministarstva. Uvidom u priloženu dokumentaciju, Ministarstvo je utvrdilo da zahtjev nije potpun, te da sadrži nedostatke i nepravilnosti zbog kojih nije moguće izvršiti upis u Registar udruženja. Ministarstvo je aktom broj: UP09-07-1-1633/23 od 10.7.2023. godine zatražilo ispravku i dopunu zahtjeva.

Podnositelj Zahtjeva je podneskom od 19.7.2023. godine izvršio izmjene i dopune zahtjeva, te uz Zahtjev priložilo slijedeću dokumentaciju: Zapisnik sa sjednice Skupštine Udruženja broj: 331-5/23 od 31.5.2023. godine; Odluku Udruženja broj: 331-2/23 od 31.5.2023. godine u dva primjerka; Odluku

Udruženja broj: 331-4/23 od 31.5.2023. godine sa ovjerenim potpisom i kopijom lične karte imenovane osobe i dokaz o uplati administrativne takse.

Uvidom u priloženu dokumentaciju utvrđeno je da su ispunjeni uslovi propisani čl. 8. i 33. Zakona o udruženjima i fondacijama Bosne i Hercegovine i članom 4. Pravilnika o načinu vođenja registra udruženja i fondacija Bosne i Hercegovine i stranih i međunarodnih udruženja i fondacija i drugih neprofitnih organizacija o načinu vođenja Registra udruženja za upis promjena u Registru udruženja, te je riješeno kao u dispozitivu.

The Ministry of Justice of Bosnia and Herzegovina, acting upon the request submitted by the Association Centre for Energy, Environment and Resources, seated in Sarajevo, Podgaj Street no. 8, regarding the entry of changes in the Registry of Associations, in accordance with Article 43, paragraph 2 of the Law on Associations and Foundations of Bosnia and Herzegovina ("Official Gazette of BiH", number 32/01, 42/03, 63/08, 76/11 and 94/16) and Article 4, paragraph 1 of the Rulebook on the Manner of Keeping the Registry of Associations and Foundations of Bosnia and Herzegovina, and Foreign and International Associations and Foundations and Other Non-profit Organizations ("Official Gazette of BiH", number 68/18), hereby issues the following

DECISION

1. The following changes are made in the Registry of Associations of the Ministry of Justice of Bosnia and Herzegovina with regard to the Association Centre for Energy, Environment and Resources, seated in Sarajevo, Podgaj 8, registered under number 385, Registry Book I, on 12 January 2006:

- Change of the Association Statute, no. 03/13 dated 15 July 2013

The logo of the association is amended as follows:

The Association logo consists of a symbol and a textual part. The symbol consists of three elements, including three curves, one of which ends with a droplet, the second with a leaf, while the third largest joins the mentioned elements into one whole. The textual part consists of the abbreviated name and the full name of the Association in English. The abbreviated name of the Association is written in capital letters, the Merge Light font is in turquoise colour, and the full name of the Association in English is written in Verdana font, a darker turquoise colour.

- Nadira Berbić, the vice president of the Association, is dismissed from the duty of representing the Association in legal transactions.
- The following person is registered and authorized to represent the Association in legal transactions:
Sadžida Hafizović, vice president of the Association, alongside
Šejla Mahmutović, president of the Association, who represents the Association according to the Decision number UP09-07-1-1867/21 dated 19 Oct 2021.

2. This Decision shall be published in the "Official Gazette of BiH", at the expense of the Applicant.

Statement of Grounds

The Association Centre for Energy, Environment and Resources, seated in Sarajevo, Podgaj Street no. 8, was registered on 12 January 2006 in the Registry of Associations of the Ministry of Justice of Bosnia and Herzegovina, under number 385, Registry Book I.



On 16 June 2023, the Applicant submitted a Request for the registration/entry of changes in the Registry of Associations kept by this Ministry. By examining the submitted documentation, the Ministry has established that the Request is incomplete, that it contains deficiencies and irregularities because of which is not possible to carry out the changes in the Registry of Associations. The Ministry requested a correction and supplement with act no. UP09-07-1-1633/23 from 10.07.2023.

On 19 July 2023, the Applicant has attached the following corrections and supplements to the Request submitted: Minutes of the Association Assembly session no. 331-5/23 dated 31 May 2023; Decision on the dismissal and appointment of the Association's members dated 7 March 2022; Decision of the Association no: 331-2/23 from 31 May 2023 in two copies; Decision of the Association no: 331-4/23 dated 31 May 2023 with a certified signature and a copy of the identity card of the person authorized to represent the Association in legal transactions and proof of payment of the administrative fee.

Upon examination of the submitted documents, it has been determined that the conditions stipulated in Article 8 and Article 33 of the Law on Associations and Foundations of Bosnia and Herzegovina and Article 4 of the Regulation on Keeping the Registry of Associations and Foundations of Bosnia and Herzegovina, and Foreign and International Associations and Foundations and Other Non-profit Organizations, regarding the entry and registration of changes, have been duly met, whereas the Applicant's request was resolved as stated in the enacting clause of this Decision.

An administrative fee in the amount of BAM 50.00 was charged for this Decision, relevant to the entry of changes in the Register of Associations, in accordance with Tariff No. 108 of the Decision on Supplementing the Tariff of Administrative Fees ("Official Gazette of BiH" number: 73/17).

Legal remedy: No appeal is allowed against this Decision; however, an administrative dispute may be initiated before the Court of BiH, within 60 days from the day of receipt of this Decision.

Below the abbreviated name is the full name of the Association in English, in latin script, the Verdana font is a darker turquoise colour.
